
IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. The above NRI/OCI candidates provisionally selected for admission to B.V.Sc. & A.H. programme are advised to report in person to the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur for registration w.e.f. 20.01.2023 to 23.01.2023 and get themselves registered as per Mode of Registration described in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23.
2. The above selected candidates must have to produce their original certificates and other relevant documents relating to admission for verification to the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur at the time of registration/admission.
3. The above NRI/OCI candidates selected for admission shall have to pay requisite fee on or before the last date of registration in the form of demand draft in US \$ issued against the bank account of NRI in the country in which he/she is residing or in the shape of demand draft in equivalent Indian currency issued against his/her NRI account, maintained in India. In the latter case, the candidate is required to submit a certificate from the bank that the draft has been issued against his/her parents'/guardian's NRI account. The demand draft should be drawn in favour of the Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled bank at Palampur, India. However, the OCI card-holder can deposit the fee in the Comptroller's account FCRA A/C No. 34854349548 and proof thereof be submitted in the office of the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur at the time of registration.
4. If the NRI/OCI candidate fails to register himself/herself as per Mode of Registration and pay the fee by the due date of registration, his/her candidature will be cancelled.

5. If the candidate fails to deposit the prescribed fee on or before last date of registration and time and gets himself /herself registered in person during the days of registration, his/her candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.
6. The NRI/OCI candidate shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus at the time of registration.
7. At the time of admission and in the subsequent years, the student shall be required to fill online Anti Ragging Undertaking at www.amanmovement.org. OR www.antiragging.in.
8. For dates of registration, the above candidates will have to remain in touch with the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences as well as website of this University.
9. The SOPs to contain the spread of COVID-19 pandemic issued by the concerned Authorities from time to time will be followed in letter and spirit.
