IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. The above provisional select/waiting list for admission to B.Tech. (Food Technology) programme is on the basis of merit score of ICAR AIEEA (UG)-2022 and subject to fulfilling the eligibility criteria for admission as well as availability of number of seats for B.Tech. (Food Technology) programme for the Academic Year 2022-23.
2. Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance tests as declared by NTA/ICAR for admission to the respective programme. In the eventuality of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the select /waiting list of the candidates who have obtained equal marks in the ICAR AIEEA (UG)-2022 is purely tentative. The merit of the candidates in such cases for admission will be decided at the time of respective counseling-cum-admission rounds and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his/her original certificates/documents including rank card of ICAR AIEEA (UG)-2022 relating to admission on the spot by the counseling-cum-admission committee.
3. The provisional select list for 1st Round of Counseling-cum-Admission for all categories excluding SFS seats for admission to B.Tech. (Food Technology) programme for the Academic Year 2022-23 containing all the instructions is being issued separately. The provisional select list for 2nd Round of Counseling-cum-Admission to B.Tech. (Food Technology) programme for SFS seats and the seat(s) remained vacant of any category in 1st Round Counseling-cum-Admission will immediately be issued after the 1st Round of Counseling-cum-Admission and available on the University website. Similarly, if there still remain vacant seat(s) of any category, the provisional select list for 3rd Round of Counseling-cum-Admission for B.Tech. (Food Technology) programme for the respective category will be issued. The candidate shall have to check his/her name in the respective provisional select list of the concerned Round of Counseling-cum-Admission for B.Tech. (Food Technology) programme and shall have to appear before the Counseling-cum-Admission Committee on the scheduled date, time and venue for respective Round of Counseling-cum-Admission failing which his/her right for admission including in the subsequent round of Counseling-cum-Admission for B. Tech. (Food Technology) programme shall be forfeited. No separate correspondence in this regard will be made.
4. The admission to B.Tech. (Food Technology) programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.
5. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23.
6. While every care has been taken in preparing the select/waiting list for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
