It is hereby notified that on the basis of the Final Provisional Select/Waiting list of the shortlisted candidates notified vide notification No.QSD.7-2/(Admission) CSKHPKV(Acad)/2022/956-80 dated 06.01.2023 and after having conducted the 1st Round of Counseling-cum-Admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme, the candidates as per Annexure have provisionally been selected categorywise against the vacant seats and the Self Financing Seats for 2nd Round of Counseling-cum-Admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme at CSKHPKV, Palampur for the Academic Year 2022-23 with the following conditions/important instructions to the candidates:

- 1. The provisionally **selected** candidates as per Annexure **only** are advised to report in person to the Dean, Postgraduate Studies, CSKHPKV, Palampur for Counseling-cum-Admission on 17.01.2023 from 10.00 AM to 4.00 PM and shall have to show ICAR AIEEA(PG)-2022 score card and Rank Card alongwith all the original certificates/documents relating to admission to the Counseling-cum-Admission Committee at the time of 2nd Round of Counseling-cum-Admission and also to submit the counseling proforma (To be downloaded from the University website) duly filled in all respects alongwith two copies of his/her recent photograph and two sets of self-attested photocopies of all required documents/certificates relating to admission as mentioned in the Counseling Performa at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admission 2022-23, at the time of document verification failing which the candidate shall have no right for admission to the programme.
- 2. Where two or more candidates have obtained equal marks in ICAR AIEEA (PG)-2022, their merit will be decided on the basis of rank in the ICAR AIEEA (PG)-2022 entrance test as declared by ICAR/NTA for admission to M.Sc. Agriculture & M.Sc. Basic Sciences programmes. In the eventually of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the select/waiting list of the candidate who have obtained equal marks in the ICAR AIEEA (PG)-2022 is purely tentative. The merit of the candidates in such cases for admission will be decided at the time of respective counseling-cum-admission rounds and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his original certificates/documents including rank card of ICAR AIEEA (PG)-2022 relating to admission on the spot by the Counseling-cum-Admission committee.
- Admission under sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure Prospectus Entrance Test Based Admissions for the year 2022-2023.

- 4. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus at the time of admission.
- 5. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.
- 6. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of M.Sc. Agriculture & M.Sc. Basic Sciences programmes.
- 7. After verification of documents including medical fitness certificate, the candidates found eligible for admission shall have to deposit their requisite fee except hostel charges on the same day directly in the Comptroller's Account No: 32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and will have to submit the computer generated receipt or bank receipt as a proof of deposit of fee in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur on 17.01.2023 upto 4.00 PM.
- 8. If a candidate fails to attend the 2nd Round of Counseling-cum-Admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme as per mode of admission and deposit the fee, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit in the respective category in the next round of Counseling-cum-Admission.
- 9. The candidate who found eligible for admission after verification of his/her documents by the Counseling-cum-Admission Committee but fails to deposit the prescribed fee on the same day of 2nd Round of Counseling-cum-Admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme on 17.01.2023 upto 4.00 PM, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit in the respective category in the next round of Counseling-cum Admission.
- 10. The candidates finally selected for admission by the Counseling-cum-Admission Committee and deposited the requisite fee on the same day, shall have to report for registration for admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme on 23.01.2023.
- 11. At the time of admission and in the subsequent years, every student shall be required to fill online Anti Ragging Undertaking at www.amanmovement.org (OR) w.w.w.antiragging.in.
- 12. The admission to M.Sc. Agriculture & M.Sc. Basic Sciences programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.
- 13. The classes to the programme will be commenced/conducted w.e.f. 24.01.2023.
- 14. While every care has been taken in preparing the list of 2nd round of Counseling-cum-admission for the above said programmes, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
