ii) *Since none of the candidates in Animal Science Major Subject Group of AIEEA (PG)-2022 have mentioned any choice of sub-subjects in the online application form shall be considered only in the Final Round of Counseling/Mop-up Round to be conducted on 06.02.2023.*

Note: *The admission of the candidate will be considered in the same discipline(s) of Master's programme of this University i.e. in the sub-subjects of Major Subject Groups of ICAR AIEEA (PG)-2022 in which he/she appeared in ICAR AIEEA (PG)-2022.*

IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. The above final provisional select/waiting list for admission to M.V.Sc. (Veterinary Science) programme is on the basis of merit score of ICAR AIEEA (PG)-2022 and subject to fulfilling the eligibility criteria for admission as well as availability of number of seats for M.V.Sc. (Veterinary Science) programme for the Academic Year 2022-23.
2. Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance tests as declared by NTA/ICAR for admission to the respective programme. In the eventually of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the select/waiting list of the candidates who have obtained equal marks in the ICAR AIEEA (PG)-2022 is purely

tentative. The merit of the candidates in such cases for admission will be decided at the time of respective counseling-cum-admission rounds and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his/her original certificates/documents including rank card of ICAR AIEEA (PG)-2022 relating to admission on the spot by the counseling-cum-admission committee.

3. The provisional select list for 1st Round of Counseling-cum-Admission for all categories excluding SFS seats for admission to M.V.Sc. (Veterinary Science) programme for the Academic Year 2022-23 containing all the instructions is being issued separately. The provisional select list for 2nd Round of Counseling-cum-Admission to M.V.Sc. (Veterinary Science) programme for SFS seats and the seat(s) remained vacant of any category in 1st Round Counseling-cum-Admission will immediately be issued after the 1st Round of Counseling-cum-Admission and available on the University website. Similarly, if there still remain vacant seat(s) of any category, the provisional select list for 3rd Round of Counseling-cum-Admission for M.V.Sc. (Veterinary Science) programme for the respective category will be issued. The candidate shall have to check his/her name in the respective provisional select list of the concerned Round of Counseling-cum-Admission for M.V.Sc. (Veterinary Science) programme and shall have to appear before the Counseling-cum-Admission Committee on the scheduled date, time and venue for respective Round of Counseling-cum-Admission failing which his/her right for admission including in the subsequent round of Counseling-cum-Admission for M.V.Sc. (Veterinary Science) programme shall be forfeited. No separate correspondence in this regard will be made.
4. The admission to M.V.Sc. (Veterinary Science) programme shall be made as per the provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University.
5. Admissions under Sports/Co-curricular activities sub category will be governed as per criteria mentioned in Annexure-I of the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23.
6. While every care has been taken in preparing the select/waiting list for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
