**IMPORTANT INSTRUCTIONS TO THE CANDIDATES**


1. The above provisional select/waiting list for admission to Doctoral programmes is on the basis of merit score of ICAR AICE-JRF/SRF (Ph.D.)-2022 & other eligibilities/criteria and is purely temporary. If any candidate has any objection or finds that his/her name is missing in the above shortlisted list, he/she is free to point out the same upto 31.12.2022 by writing to the undersigned through e-mail [contactpetskhpkv@gmail.com](mailto:contactpetskhpkv@gmail.com) by mentioning his/her application number and name failing which no claim/representation of the candidate will be entertained thereafter.
2. Where two or more candidates have obtained equal marks in the respective entrance test, their merit will be decided on the basis of rank in the respective entrance tests as declared by NTA/ICAR for admission to the respective programme. In the eventually of same rank, the merit would be decided on the basis of percentage of aggregate marks obtained in the concerned subjects of the qualifying examination. If there is still a tie, then the candidate older in age will be considered higher in the merit. Accordingly, the candidate who have obtained equal marks in the ICAR AICE-JRF/SRF (Ph.D.)-2022, the merit of such candidates for admission will be decided at the time of counseling-cum-admission process on the spot and the candidate(s) higher in merit as per mode of admission will be admitted after scrutinizing his original certificates/documents including score card and rank card of ICAR AICE-JRF/SRF (Ph.D.)-2022 relating to admission on the spot by the counseling-cum-admission committee.
3. Only those candidates who have passed their qualifying examination from ICAR accredited Universities/Institutes shall be eligible for admission in Doctoral programmes.





4. After verification of objection, if any, raised/pointed out by the candidate(s), the provisional final list for counseling-cum-admission to the respective Doctoral programme will be issued separately which shall be available on the University website <http://hillagric.ac.in> containing all the instructions/procedure for counseling-cum-admission to Doctoral programme. If any correction/error is noticed during verification, the same shall also be rectified by the office for which no objection will be entertained.
5. While every care has been taken in preparing the provisional select/waiting list for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.


