- 2. All the candidates who appeared in NEET (UG)-2022 and filled the online application form with requisite fee for admission to B.V.Sc. & A.H programme of this University will only be entitled to appear in final round of counseling/mop-up round for admission to B.V.Sc. & A.H. programme.
- 3. All the candidates who appeared in ICAR AIEEA (UG)-2022 and filled the online application form with requisite fee for admission to B.Sc. (Hons.) Agriculture programme of this University will only be entitled to appear in final round of counseling/mop-up round for admission to B.Sc. (Hons.) Agriculture programme.
- 4. All the candidates who appeared in ICAR AIEEA (UG)-2022 and filled the online application form with requisite fee for admission to B.Tech. (Food Technology) programme of this University will only be entitled to appear in final round of counseling/mop-up round for admission to B.Tech. (Food Technology) programme.
- 5. The candidates wishing to take admission through Final Round of Counseling/Mopup Round will have to appear for the Final Round of Counseling/Mop-up Round of the respective programme on the above specified dates and at the respective venue mentioned above upto 11.00 AM for counseling.
- 6. The candidates shall have to mark their attendance in the attendance sheet/register kept at the venue of counseling for the purpose positively by 11.00 AM for the respective programme.
- 7. The admissions through Final Round of Counseling/Mop-up Round shall be made as per provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 for B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture and B.Tech Food Technology programmes and subsequent notifications issued by the University.
- 8. The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.
- 9. If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in Final Round of Counseling/Mop-up Round.
- 10. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of Final Round of Counseling/Mop-up Round. In such cases, the candidates shall have to attend the Final Round of Counseling/Mop-up Round.
- 11. The candidates shall have to bring all the original certificates/documents relating to admission including NEET(UG)-2022 score card for admission to B.V.Sc. & A.H. programme and ICAR AIEEA (UG)-2022 score card for admission to B.Sc.(Hons.) Agriculture Programme and B.Tech Food Technology programme with two copies of his/her recent photograph and two sets of self-attested copies of all the required documents/certificates relating to admission as mentioned in the counseling proforma at Annexure IX of the Information Brochure and Prospectus Entrance Test Based Admissions 2022-23 alongwith counseling proforma (to be downloaded from the University Website http://hillagric.ac.in) duly filled in all respect for admission through Final Round of Counseling/Mop-up Round and shall have to

show to the Counseling-cum-Admission Committee at the time of Final Round of Counseling/Mop-up Round of the respective programme.

12. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of Final Round of Counseling/Mop-up Round.

- 13. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure IV as per medical and physical fitness standards prescribed in Annexure V of the Information Brochure & Prospectus Entrance Test Based Admissions-2022-23 at the time of Final Round of Counseling/Mop-up Round.
- 14. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Entrance Test Based Admissions 2022-23 and subsequent notifications issued by the University. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
- 15. The candidates appearing in Final Round of Counseling/Mop-up Round in case they are offered a seat for admission, must have to deposit the requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day.
- 16. If a candidate fails to register as per Mode of Registration and deposit the requisite fee on the date and time of Final Round of Counseling/Mop-up Round, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
- 17. The vacancy position indicated above may vary and also arise of any category at the time of Final Round of Counseling/Mop-up Round for filling up.
- 18. While every care has been taken in preparing the vacancy position for the above said programme, however, possibility of inadvertent error cannot be ruled out. The University reserves the right to rectify the same later on.
