If the seats in any category {except the categories Wards of Kashmiri Migrants and Kashmiri Pandits/Kashmiri Hindu families (non-migrant), PMSSS for UT of J & K and Ladakh and Self-Financing Seats} remain vacant due to non-availability of eligible candidates, will be added to general category at the time of final round of counseling/mop-up round on the spot and filled up accordingly. During this process, if seats of H.P. Bonafide remain vacant, the non-HP Bonafide candidates can also be considered.

In case the seats of Ward of Kashmiri Migrant and Kashmiri Pandits/Kashmiri Hindu families (non-migrants) and PMSSS for UT of \check{J} & K and Ladakh remains vacant at the time of final round of counseling/mop-up round (upto 11.00 AM), such seat(s) shall be converted to Self Financing Seat(s) and shall be filled up on the spot at the time of final round of counseling/mop-up round.

Note:

No separate communication will be made.

The candidates who have already applied online for the respective merit based 1. Undergraduate programme(s) of this University will only be entitled to appear for final round of counseling/mop-up round of counseling cum admission for the respective programme(s).

The candidates wishing to take admission through Final Round of Counseling/Mop-Up Round will have to appear for the same on the above dates upto 11.00 AM for 3. counseling at the venue of counseling as indicated above for the respective programme.

- 4. The candidates shall have to mark their attendance in the attendance sheet/ register kept for the purpose at the venue of counseling in the office of the concerned Dean, positively by 11.00 AM.
- 5. The admissions through Final Round of Counseling/Mop-Up Round will be made as per provisions contained in Information Brochure & Prospectus Merit Based Admissions 2022-23 and subsequent notifications issued by the University.
- 6. The candidature of the candidate to the programme will only be considered against the specific category for admission as he/she has applied for the said category at the time of filling online application form.
- 7. If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for Self Financing seat shall not be considered in final round of counseling/mop-up round.
- 8. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of final round of counseling/mop-up round. In such cases, the candidates shall have to attend the final round of counseling/mop-up round.
- 9. The candidates shall have to show all original certificates/documents relating to admission to the Counseling-cum-Admission Committee of the University at the time of counseling-cum-admission. Simultaneously, the candidate shall have also to submit two copies of his/her recent photograph and two sets of self-attested copies of all the relevant certificates/documents (as mentioned in the Counseling Proforma) relating to admission alongwith counseling proforma at Annexure II of the Information Brochure and Prospectus Merit Based Admissions 2022-23 (to be downloaded from the University Website http://hillagric.ac.in) duly filled in all respects, at the time of document verification to the Counseling-cum-Admission Committee for admission through final round of counseling/mop-up round of the respective programme.
- 10. The admission shall be made on the basis of merit list (as per mode of admission) to be drawn on the day of Final Round of Counseling/Mop-Up Round.
- 11. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure V as per medical and physical fitness standards prescribed in Annexure VI of the Information Brochure & Prospectus Merit Based Admissions 2022-23 at the time of final round of counseling/mop-up round.
- 12. If it is found that any relevant information has been concealed or any certificate/degree/testimonial is found fake/false at any point of time, the admission of the candidate shall be cancelled forthwith at the cost and risk of the candidate. It may also be noted that the relevant certificates/documents should be on the prescribed format as mentioned in the Information Brochure & Prospectus Merit Based Admissions 2022-23 and subsequent notifications issued by the University. The candidates belonging to Economically Weaker Sections (EWSs) shall have to produce the Income & Asset Certificate of gross annual income of his/her family below 4.00 Lakh (Rupees four Lakh only) indicating the year of its validity issued by the competent authority failing which they shall have no right for admission to EWSs category of the respective programme.
- 13. The candidates appearing in final round of counseling/mop-up round in case they are offered a seat for admission, must have to deposit requisite amount of fee except hostel charges in the Comptroller, CSKHPKV, Palampur Account No.32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or any other bank transaction and submit the computer generated receipt as a proof of deposit the fee on the spot on the same day.

- 14. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
- 15. The vacancy position indicated above may vary and also arise of any category at the time of final round of counseling/mop-up round for filling up.
