2. The candidates wishing to take admission through 2nd Walk-in-Interview will have to appear for the same on 20.09.2017 upto 11.00 AM at the venue of counseling as indicated above for the respective programme.
3. The candidates shall have to mark their attendance in the attendance sheet/register kept at the venue of counseling for the purpose on 20.09.2017 upto 11.00 AM.
4. The admissions through 2nd Walk-in-Interview shall be made as per provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2017-18 for B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Ag., M.Sc.(Community Science), M.Sc. & M.V.Sc. Programmes.
5. If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for self financing seat shall not be considered in Walk-in-interview.

6. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of 2nd Walk-in-Interview. In such cases, the candidates shall have to attend the 2nd Walk-in-Interview.
7. The candidates shall have to bring all the original certificates/testimonials and other documents relating to admission with one set thereof duly self attested for admission through 2nd Walk-in-Interview.
8. The following categories of candidates will be entitled to appear in 2nd Walk-in-Interview:
 - a. All such candidates whose names figured in the select list but did not register on the specified date due to any reason,
 - b. The waiting list candidates who either did not register in spite of a vacancy or who were too low in the merit list to be admitted, and
 - c. All other eligible candidates who have appeared in ET - 2017.
9. The admission shall be made on the basis of merit list (As per mode of admission) to be drawn on the day of 2nd Walk-in-Interview.
10. The candidates appearing in 2nd Walk-in-Interview must have to bring a demand draft of requisite amount of fee except hostel charges and deposit the same on the spot in case they are offered a seat for admission.
11. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
12. The vacancy position indicated above may vary at the time of 2nd Walk-in-Interview.


