2. The candidates wishing to take admission through 2<sup>nd</sup> Walk-in-Interview will have to appear for the same on the above specified date and time at the venue of counseling as indicated for the respective programme.
3. The candidates shall have to mark their attendance in the attendance sheet/register kept at the venue of counseling for the purpose on the above specified date upto 11.00 AM.



4. The admissions through 2<sup>nd</sup> Walk-in-Interview shall be made as per provisions contained in the Information Brochure & Prospectus Entrance Test Based Admissions 2018-19 for B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc. Ag., M.Sc. (Community Science), M.Sc. & M.V.Sc. Programmes.
5. If a candidate has not opted for Self-Financing seat at the time of filling online application form, his/her candidature for self financing seat shall not be considered in Walk-in-interview.
6. In case of non-availability of HP Bonafide candidates, the candidature of Non-H.P. Bonafide candidates can be considered against the vacant seat(s) of HP Bonafide category, if any, at the time of 2<sup>nd</sup> Walk-in-Interview. In such cases, the candidates shall have to attend the 2<sup>nd</sup> Walk-in-Interview.
7. The candidates shall have to bring all the original certificates/testimonials and other documents relating to admission with one set thereof duly self attested for admission through 2<sup>nd</sup> Walk-in-Interview.
8. All eligible candidates who appeared in ET-2018 are entitled to appear in 2<sup>nd</sup> Walk-in-Interview.
9. The admission shall be made on the basis of merit list as per mode of admission to be drawn on the day of 2<sup>nd</sup> Walk-in-Interview.
10. The candidates appearing in 2<sup>nd</sup> Walk-in-Interview must have to bring a **demand draft of requisite amount** of fee except hostel charges drawn in favour of the Comptroller, CSKHPKV, Palampur and deposit the same on the spot in case they are offered a seat for admission.
11. If a candidate fails to register as per Mode of Registration and deposit the requisite fee by the due date and time of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category. However, it will be the sole responsibility of the candidate to verify his/her selection to the programme applied for.
