The candidates selected for admission will have to deposit the requisite fee except hostel charges directly in the Comptroller's Account No:32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or otherwise and will have to submit the computer generated receipt or bank receipt as a proof of deposit of fee in the office of the Dean, College of Home Science, CSKHPKV, Palampur at the time of registration on 26.07.2016 upto 5.00 PM.
