

IMPORTANT INSTRUCTIONS TO THE CANDIDATES

1. The selected candidates are advised to report in person to the Dean, College of Home Science, CSKHPKV, Palampur for registration on 26.07.2016 from 10.00 AM to 5.00 PM and get themselves registered as per Mode of Registration in the Information Brochure and Prospectus Merit Based Admissions 2016-17 for B.Sc. Physical Sciences (Physics, Chemistry & Mathematics), B.Sc. Life Sciences (Botany, Zoology & Chemistry), B.Sc. (Hons.) Home Science, B.Sc.(Hospitality & Hotel Administration), B.Tech.(Food Technology) & Doctoral Programmes.
2. The selected candidates will have to deposit their requisite fee except hostel charges directly in the Comptroller's Account No:32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or otherwise and will have to submit the computer generated receipt or bank receipt as a proof of deposit of fee in the office of the Dean, College of Home Science, CSKHPKV, Palampur at the time of registration on 26.07.2016 upto 5.00 PM. The candidates can also deposit the fee by way of demand draft drawn in favour of the Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (Code 3632) or payable at Palampur (in case of any other bank) and submit the said draft in the office of the Dean, College of Home Science, CSKHPKV, Palampur on the day of registration i.e. 26.07.2016 upto 5.00 PM.
3. If a candidate fails to register himself/herself as per Mode of Registration and deposit the fee by the due date of registration, his/her candidature will be cancelled and the seat shall be allotted to the next candidate on merit, in the respective category.
4. The candidate who fails to deposit the prescribed fee by the date of registration i.e. 26.07.2016 upto 5.00 PM and gets himself/herself registered in person, his/her candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.
5. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure V as per medical physical and fitness standards prescribed in Annexure VI of the Prospectus at the time of registration.


