
IMPORTANT INSTRUCTIONS TO THE CANDIDATE

1. The NRI candidate is advised to report in person to the Dean, Dr. G.C. Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur for registration during the days of registration w.e.f. 26.07.2016 to 28.07.2016 from 10.00 AM to 5.00 PM and get himself/herself registered as per Mode of Registration described in the Information Brochure & Prospectus Entrance Test Based Admissions 2016-17 for B.V.Sc. & A.H., B.Sc. (Hons.) Agriculture, M.Sc.(Agriculture), M.Sc.(Vegetable Science), M.Sc.(Home Science), M.Sc. & M.V.Sc. Programmes.
2. The NRI candidate shall have to pay requisite fee on or before 28.07.2016 in the form of demand draft in US \$ issued against the bank account of NRI in the country in which he/she is residing or in the shape of demand draft in equivalent Indian currency issued against his/her NRI account, maintained in India. In the latter case, he/she is required to submit a certificate from the bank that the draft has been issued against his/her parents'/guardian's NRI account. The demand draft should be drawn in favour of the Comptroller, CSKHPKV, Palampur (H.P.), India payable at any scheduled bank at Palampur, India.
3. If the NRI candidate fails to register herself as per Mode of Registration and pay the fee by the due date of registration, his/her candidature will be cancelled.
4. If the candidate fails to deposit the prescribed fee on or before 28.07.2016 upto 5.00 PM and gets herself registered in person during the days of registration w.e.f. 26.07.2016 to 28.07.2016 upto 5.00 PM, his/her candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.
