 - c. All other eligible candidates who have appeared in ET 2016.
7. The admission shall be made on the basis of inter-se-merit list to be drawn on the day of 2nd Walk-in-Interview.

Candidates appearing in 2nd Walk-in-Interview must bring a demand draft of requisite amount of fee drawn in favour of the Comptroller, CSKHPKV, Palampur and deposit the same on the spot in case they are offered a seat for admission. Any fee deposited directly in the bank account of the Comptroller will not be considered for admission through 2nd Walk-in-Interview.


