

Negi College of Veterinary & Animal Sciences, CSKHPKV, Palampur at the time of registration on 13.07.2015 upto 5.00 PM. The candidates can also deposit the fee by way of demand draft drawn in favour of the Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (Code 3632) or payable at Palampur in case of any other bank and submit the said draft in the office of the Dean, Dr. G.C. 5. At the time of admission, every student shall be required to fill online Anti Ragging Undertaking (Affidavit) at www.amanmovement.org.


