

The selected candidates will have to deposit their requisite fee directly in the Comptroller's Account No:32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or otherwise and will have to submit the computer generated receipt or bank receipt as a proof of fee deposited in College of Home Science, CSKHPKV, Palampur at the time of registration on 27.07.2015 upto 5.00 PM. The candidates can also deposit the fee by way of demand draft drawn in favour of the Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (Code 3632) or payable at Palampur in case of any other bank and submit the said draft in the office of the Dean, College of Home Science, CSKHPKV, Palampur on the day of registration on 27.07.2015 upto 5.00PM.
3. The candidate who fails to deposit the prescribed fee by the date of registration i.e. 27.07.2015 upto 5.00 PM and gets himself/herself registered in person,


