

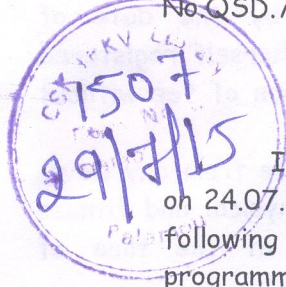



1. The above selected candidates are advised to report in person to the Dean, College of Basic Sciences, CSKHPKV, Palampur for registration on 27.07.2015 up to 5.00 PM and get themselves registered as per Mode of Registration described in the Prospectus 2015-16.
2. The selected candidates will have to deposit their requisite fee directly in the Comptroller's Account No:32088116733 (IFSC: SBIN0003632) at SBI, HPAU, Palampur through internet banking or otherwise and will have to submit the computer generated receipt or bank receipt as a proof of fee deposited in College of Basic Sciences, CSKHPKV, Palampur at the time of registration on 27.07.2015 upto 5.00 PM. The candidates can also deposit the fee by way of demand draft drawn in favour of the Comptroller, CSKHPKV, Palampur payable at SBI, HPAU, Palampur (Code 3632) or payable at Palampur in case of any

other bank and submit the said draft in the office of the Dean, College of Basic Sciences, CSKHPKV, Palampur on the day of registration on 27.07.2015 upto 5.00 PM.

3. The candidate who fails to deposit the prescribed fee by the date of registration i.e. 27.07.2015 upto 5.00 PM and gets himself/herself registered in person, his/her candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.
4. The candidates shall have to produce medical fitness certificate from any Govt. Hospital in the format given at Annexure V as per medical physical and fitness standards prescribed in Annexure VI of the Prospectus at the time of registration.
5. At the time of admission, every student shall be required to fill online Anti Ragging Undertaking (Affidavit) at www.amanmovement.org.




