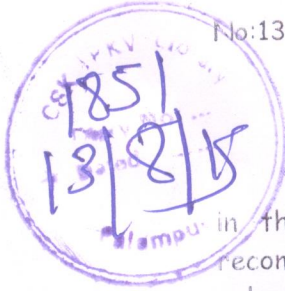

The candidates can also deposit the fee by way of demand draft drawn in favour of the Comptroller, CSKHPKV, Palampur payable

at SBI, HPAU, Palampur (Code 3632) or payable at Palampur (in case of any other bank) and submit the said draft in the office of the Dean, Postgraduate Studies, CSKHPKV, Palampur on the day of registration i.e. 17.08.2015 upto 5.00 PM.

3. The candidate who fails to deposit the prescribed fee by the date of registration i.e. 17.08.2015 upto 5.00 PM and gets himself/herself registered in person, his/her candidature will be cancelled. Mere deposition of fee without registration in person will not entitle the candidate to a seat.


