Notice Inviting Quotation for the purchase of Anti-rabies vaccine and syringes.

Sealed quotations are invited by the undersigned for the purchase of Anti-rabies vaccine and syringes as per specifications given below. The quotation should be strictly according to the terms and conditions as noted below, otherwise the quotations will not be accepted.

## Description/ Specifications of Injection RABIVAX-S:

- Anti-rabies vaccine, Human LP, should be freeze dried purified vero Cell inactivated rabies antigen with 1 mL dilutent
- 2. Vaccine should be in freeze dried form and should be stable between 2-8 degree Celsius.
- The vaccine upon reconstitution with accompanied diluent should have volume of 1 mL and should be suitable for intradermal use.
- 4. The vaccine and diluent should be free from any impurities and contamination.
- 5. Shelf life of vaccine should be at least 12 months.
- 6. The vaccine vials should be supplied in temper proof packaging.
- 7. The supply should be made under proper cold chain conditions.

## TERMS & CONDITIONS:

- The quotations must be sent in a scaled cover and subscribed as "Quotations due on 20.07.2024" already
  on the envelope otherwise it will be rejected out rightly.
- 2. The rates should be quoted FOR, office of the Dean, DGCN COVAS, CSKHPKV. Palampur inclusive of all charges.
- 3. The prices should be quoted mentioning all charges such as taxes, sales tax, excise duty, packing and forwarding, if any. Nothing will be paid extra, if not quoted.
- 4. The quotation should reach in the office of the undersigned before 20.07.2024 at 5:00 PM.

- 5. The quotations would be opened on 22.07,2024 at 03:00PM. Representatives owners may attend the opening process.
- 6. GST CST number and Authorized Dealership Certificate (if any) duly attested by the firm should be attached.
- 7. The quantity can be decreased or increased at the discretion of the undersigned, who reserves the right to consider or reject the quotation if not as per specification and provisions here in.
- 8. The quotation should be submitted only if the articles are in stock and can be supplied promptly.
- 9. The supply will have to be made within 15 days of the confirmed supply order.
- 10. The delivery of stores is to be affected within the stipulated time otherwise the order will be cancelled forthwith at his own risk, expenses and order will be placed with the next firm.
- 11. The prices quoted should strictly be adhered to the specification given in the list. The quotations received after the date will not be considered.
- 12. If the total value of the quote exceeds Rs. 1.00 Lakh, the quotation should be accompanied with an earnest money i.e. @ 20% of the estimated value of goods in the shape of F.D.R. duly pledged in the name of the Comptroller, CSKHPKV, Palampur.

- 14. The quotation of advance payment through bank etc. will not be entertained as per University rule: 90% through bank and 10% on inspection and receipt of materials.
