2. The quotation cover should be super-scribed "Quotation for the replacement and upgradation of the piped Medical Oxygen supply points" due on **06/08/2024**.
3. If the total price of quoted item exceeds Rs. 1.00 Lakhs, the quotation should be accompanied with a refundable earnest money at least @2% of the total quoted amount in the shape of FDR/TDR/DD in favour of the Comptroller, CSKHPKV, Palampur. The quotation will not be considered without such EMD.
4. The make of the quoted item should be mentioned in the quotation along with the applicable warranty.

5. The rate along with Taxes should be quoted F.O.R. destination i.e. Deptt. of Vety. Surgery and radiology, DGCNCOVAS, CSKHPKV, Palampur. **The labour charges should include installation of all above-mentioned Oxygen points and the repair of exiting oxygen points and pipes; if required.
