2. The quotations received after due date will not be considered.
3. **The Rates should be quoted FOR, CSKHPKV, Palampur (i.e. Department of Agronomy, COA).**
4. The price quoted should be inclusive of all charges i.e loading/uploading, fixing, weighing, installation, packaging, insurance and other forwarding charges etc. **(Nothing will be paid extrc).**
5. GST should be shown separately and GST No. may be mentioned in the quotation.
6. **Price list should be attached.**
7. **The price should be quoted separately for each item and then total cost should be mentioned for all works.**
8. **The lowest price will be considered on overall lowest price basis.**
9. The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
10. Supply immediately after confirmed order.
11. The quotation should be submitted only if the items can be supplied promptly on demand.
12. The price quoted should be strictly according to the specifications stated above.
13. The University reserves the right to accept or reject the quotations without assigning any reason.
14. The payment will be made after satisfactorily installation and Inspection Report of the material to be conducted by the Inspection Committee so constituted for the purpose by the University.
15. No condition of advance payment or payment in cash will be considered.
16. The Quantity can be increased or decreased.
17. **The E-way bill is to be required along with actual bill.**
18. If the total value of the purchase exceeds **Rs.1.00 Lakh**, the quotation should be accompanied with an **earnest money i.e @ 2%** of the estimated value of goods in the shape of **F.D.R** duly pledged in the name of the **Comptroller, CSKHPKV, Palampur**. The earnest money if any, already deposited/lying in the office of undersigned will not be considered for current quotation. **The quotations without EMD will not be considered.**
19. **Performance security @ 5%** of the **whole amount** of the total supply will be obtained from the successful bidder before placing the supply order.
20. The conditional quotations will not be entertained.
21. **Authorization Dealer Certificate and warranty certificate duly attested** must be attached with quotation.
22. The tender should accompany the satisfactory user report/certificate from the Institutions to whom the said equipment earlier supplied by the firm.
