Notice Inviting Quotations for the purchase of Wheat Straw Blocks



1. The quotation should reach in the office of the undersigned in a sealed cover and super-scribed "quotation for the purchase of **Wheat Straw Blocks**" by 14-10-2024 upto 5.00 PM. The quotation will be opened on 15-10-2024 at 11.00 AM.
2. The rates should be quoted F.O.R. at Livestock Farm Complex inclusive of all charges.
3. The University reserves the right to consider or reject any of quotation without assigning any reason.
4. The University reserves the right not to purchase any of the material.
5. The prices should be quoted as per specifications given in NIQ.
6. The quantity of the material can be increased or decreased.
7. The condition of advance payment or payment through cash etc. will not be considered.
8. The quotations received after due date will not be considered.
9. The payment will be made after satisfactory Inspection Report of the Inspection Committee so constituted for the purpose by the University.
10. GST extra, if any and GST No. may be mentioned in the quotation.
11. Each quotation should be accompanied with a refundable earnest money @ 2% of the total amount for the supply of the material if exceeds Rs.1.00 lakh in the shape of FDR/TDR pledged in favour of the Head, Deptt. of Livestock Farm Complex, COVAS, CSK HPKV, Palampur. Without EMD the quotations will not be considered.
12. The supply of material is to be arranged by the supplier as and when required by the University.
13. The supplier will adhere to the provision of Motor Vehicle Act for transportation of machinery/equipment.
14. The conditional quotation will not be entertained.
