- 3. Earnest money, in the shape of FDR of a scheduled bank situated in H.P. duly pledged in favour of The Executive Engineer(C) must accompany the application while applying for issue of tender form. The earnest money in cash will not be entertained.
- 4. The tenders without earnest money, conditional and un-balanced tenders will be summarily rejected. Telephonic tender will not be accepted and rates offered in the form other than the prescribed shall not be entertained.
- In case of holidays the tender will be opened on the next working day. All other terms and conditions will remain unchanged. No tenders form shall be issued to the contractor without GST number.
- 6. The undersigned reserves the right to reject any or all the tenders without assigning any reasons.
- 7. The contractor must produce workdone certificate of last three years not below the amount put to tender.
- 8. The tender shall remain valid for 120 days after the date of opening.
- 9. No Tender will be issued to the Contractor/Contractors who have already two or more works in hand.
- 10. The contractor should produce valid copy of Registration.
- 11. Contract documents consisting of the detailed plans, complete specifications, the schedule of quantities of the various classes of the work to be done and the set of conditions of contract to be part of tender document can be seen in the office of Executive Engineer between working hours of 11.00 AM to 4.00 PM on any working day, except Sunday and public holidays.
