2. The quotations received after due date will not be considered.
3. **The Rates should be quoted FOR, CSKHPKV, Palampur (i.e. Department of Soil Science, COA).**
4. The price quoted should be inclusive of all charges i.e loading/uploading, fixing, weighing, installation, packaging, insurance and other forwarding charges etc. (**Nothing will be paid extra**).
5. GST should be shown separately and GST No. may be mentioned in the quotation.
6. The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
7. Supply immediately after confirmed order.
8. The quotation should be submitted only if the items can be supplied promptly on demand.
9. The price quoted should be strictly according to the specifications stated above.
