3. The quantity of materials can be increased or decreased.
4. The quotation received after due date will not be considered.
5. The condition of advance payment or through cash etc. will not be considered.
6. The payment will be made after satisfactorily Inspection Report of the Inspection Committee so constituted for the purpose by KVK, Mandi.
7. **If the total value of purchase exceeds Rs. 1.00 lac. The quotation should be accompanied with an earnest money i.e. @ 2% of the estimated value of goods in the shape of FDR/DD duly pledged in the name of the Programme Coordinator, KVK, Mandi at Sundernagar. The earnest money if any, already deposited/lying in the office of the undersigned will not be considered for current quotation. The quotation without EMD will not be considered.**
