- 2. The rates should be quoted F.O.R. destination i.e. **Feed Unit** of this department including of all charges. <u>Nothing will paid extra.</u>
- 3. The quantity of materials can be increased or decreased.
- 4. The University reserves the rights to consider or reject any of the quotations without assigning any reason.
