- List of machinery, Equipment as per SBD.
- Form 7/8 duly signed by the Contractor in proper format on judicial papers.
- Employee Provident Fund (EPF) registration number.
- Earnest money in the shape of FDR duly pledged in favour of the Executive Engineer (D) of Nationalized/ scheduled Bank .
- Cost of tender form either in the shape of DD in favour of the Executive Engineer (D) of nationalized/ scheduled Bank or alternatively can also be paid through e-mode in SBI Himachal Pradesh Agriculture University Palampur Account No. 10640344405 (IFSC code SBIN0003632) and the transaction slip to this effect must be uploaded on the site.
