Terms & Conditions of NIO

1. The quotations should reach in the office of Head Department of Fisheries, DGCN COVAS, CSKHPKV, Palampur in a sealed cover and super- scribed "**Quotation for Fish Feed**" on and before **06.01.2025 by 05:00PM**.
The quotation will be open on **07.01.2025 at 03:00PM** in the presence of party authorized representative, if they wish to present. In case the date of Opening is happened to be a holiday, the quotation will be opened on next working day on same time. The Head of procuring unit will intimate the same to all the members of quotation opening committee well in time.
2. The rates should be quoted F.O.R destination i.e. Fisheries, DGCN COVAS, CSKHPKV, Palampur, including of all charges. Nothing will be paid extra.
3. The quantity of materials can be increased or decreased.
4. The University reserves the right to consider or reject any of the quotations without assigning any reason.
5. The supply of the material is to be made by the supplier immediately.
6. The quotation received after due date will not be considered.
7. The condition of advance payment or through cash etc. will not be considered.
8. The quotation should be submitted only if the items can be supplied promptly on demand.
9. The price should be strictly accordingly to the specifications stated in the NIO.
10. The payment will be made after satisfactory Inspection report of the Inspection committee so constituted for the purpose by the University.
11. Each quotation should be accompanied with a refundable earnest money @2%, if the total amount for the supply of the material exceeds Rs. 1.00 lakh in the shape of fixed deposit receipts/ TDR/DD in favor of **The Comptroller, CSKHPKV, Palampur. Without EMD the quotations will not be considered.**
12. The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
13. GST may be shown separately, GST No. may be mentioned in the quotation.
