5. Affidavit regarding no near relative is working in the Estate Office as per enlistment rule .
6. Affidavit regarding not more than two works are in hand.
7. List of machinery, Equipment as per SBD.
8. Form 7/8 duly signed by the Contractor in proper format on judicial papers.
9. Employee Provident Fund (EPF) registration number.
10. Earnest money in the shape of FDR duly pledged in favour of the Executive Engineer (D) of Nationalized/ scheduled Bank .
11. Cost of tender form either in the shape of DD in favour of the Executive Engineer (D) of nationalized/ scheduled Bank or alternatively can also be paid through e-mode in SBI Himachal Pradesh Agriculture University Palampur Account No. 10640344405 (IFSC code SBIN0003632) and the transaction slip to this effect must be uploaded on the site.

The acceptance of a tender, will rest with the Executive Engineer who does not bound himself to accept the tender and reserves the authority to reject any or all of the tenders received, without assigning any reason. All tenders that do not fulfill the prescribed conditions are liable to be rejected.
