

- The quantity of materials can be increased or decreased.
- The Head also reserves the rights to consider or reject any of the quotations without assigning any reason.
- The supply of the material is to be made by the supplier immediately.
- The quotation received after due date will not be considered.
- The condition of advance payment or through cash etc. will not be considered.
- The quotation should be submitted only if the items can be supplied promptly on demand.
- The price quoted should be strictly according to the specifications stated above.
- The payment will be made after satisfactorily Inspection Report of the Inspection Committee so constituted for the purpose by the University.
- Each quotation should be accompanied with a refundable earnest money @ 2%, if the total amount for the supply of the material exceeds Rs. 1.00 lakh in the shape of fixed deposit receipts/TDR/DD in favour of the Comptroller, CSK HPKV, Palampur. **Without EMD the quotations will not be considered.**
