
#### Terms and condition alongwith required following documents, certificate & affidavits:

1. Contractor Registration(only appropriate class of Contractors should apply for bids) .
2. GST Registration .
3. Work done certificate of similar nature work as per SBD .
4. Affidavit dully attested by notary that the information submitted with the bid is true .
5. Affidavit regarding no near relative is working in the Estate Office as per enlistment rule .
6. Affidavit regarding not more than two works are in hand.
7. List of machinery, Equipment as per SBD.
8. Form 7/8 duly signed by the Contractor in proper format on judicial papers.
9. Employee Provident Fund (EPF) registration number.
10. Earnest money in the shape of FDR duly pledged in favour of the Executive Engineer (C) of Nationalized/ scheduled Bank .
11. Cost of tender form either in the shape of DD in favour of the Executive Engineer (C) of nationalized/ scheduled Bank or alternatively can also be paid through e-mode in SBI Himachal Pradesh Agriculture University Palampur Account No. 10640344405 (IFSC code SBIN0003632) and the transaction slip to this effect must be uploaded on the site.
12. The acceptance of a tender, will rest with the Executive Engineer who does not bound himself to accept the tender and reserves the authority to reject any or all of the tenders received, without assigning any reason. All tenders that do not fulfill the prescribed conditions are liable to be rejected.
13. Canvassing in connection with tenders is strictly prohibited and the tenders submitted by the contractors who resort to such act are liable for rejection.
14. Item rate tender containing percentage below or above will be summarily rejected.
15. On acceptance of the tender, the name of the technically qualified person authorized by the contractor, who is responsible for taking instructions from the Engineer -In charge shall be communicated by the contractor to the Engineer-In-Charge.
