



Annexure- A

Terms & Conditions of NIQ

1. The quotations should reach in the O/o undersigned in sealed cover and super-scribed "quotation for purchase of "PP Bags" on **05.03.2025 by 05:00 PM** in the name of Undersigned. The quotations will be opened on **06.03.2025 at 11:30 AM** in the presence of quote of their authorized representative, if present. In case the date of Opening is happened to be a holiday; the quotation will be opened on next working day on same time. The Head of Procuring Unit will intimate the same to all the members of quotation opening committee well in time.
2. The rates should be quoted F.O.R. destination i.e. **Feed Unit** of this department including of all charges. Nothing will paid extra.
3. The quantity of materials can be increased or decreased.
4. The University reserves the rights to consider or reject any of the quotations without assigning any reason.
5. The supply of the material is to be made by the supplier immediately.
6. The quotation received after due date will not be considered.
7. The condition of advance payment or through cash etc. will not be considered.
8. The quotation should be submitted only if the items can be supplied promptly on demand.
9. The price quoted should be strictly accordingly to the specifications stated in the NIQ.
10. The payment will be made after satisfactory Inspection report of the Inspection committee so constituted for the purpose by the University.
11. Each quotation should be accompanied with a refundable earnest money @2%, if the total amount for the supply of the material exceeds Rs. 1.00 lakh in the shape of fixed deposit receipts/TDR/DD in favour of the Comptroller, CSKHPKV, Palampur. **Without EMD the quotations will not be considered.**
12. The supplier will adhere to the provision of Motor Vehicle Act for transportation of material.
13. GST may be shown separately, GST No. may be mentioned in the quotation.
14. The E-way bill is to be required alongwith actual bill.
15. The quotation should accompany the satisfactory user report/certificate from the Institution to whom the said equipment earlier supplied by the firm.
