
Subject:- Regarding Career Advancement Scheme for  
Teachers/Scientists.

Sir,

I am directed to refer to your letter No. QSD.5-166/13/CSKHPKV(Estt.)/-  
10168 dated 21<sup>st</sup> February, 2014 on the subject cited above and to say that  
the matter was taken up with the Finance-E-Department in consultation with  
the F.D.(Regulation) Department who have advised as under:- (vii)

" University is advised that sub clause (viii) of clause 2 (a) of  
MHRD, Department of Higher Education, GOI, letter dated 31-  
12-2008 on the basis of which sub clause (iv) under Clause 2  
(a) exists in Annexure-II of the Notification No. Agr.- A(10)-5/82-  
III dated 30-11-2009, clearly stipulates that the higher AGP of  
Rs. 8000 will be admissible only after completion of 5 years  
service in AGP of Rs. 7000 by an incumbent i.e.  
Teacher/equivalent. Since the AGP has been introduced w.e.f.  
1-1-2006, therefore, the service period is to reckoned from 1-1-  
2006.

You are, therefore, requested to take action in the matter  
accordingly.
